**FINAL JUDGMENT OF FORECLOSURE**

This action was heard before the Court on November 19, 2025, and on the evidence presented and being otherwise duly advised in the premises:

**IT IS ORDERED AND ADJUDGED that:**

1. **Final Judgment.** There is no dispute of material facts and Plaintiff is entitled to entry of final judgment. On the evidence presented, the Court finds Plaintiff proved its *prima facie* case for foreclosure: (1) execution of a note and mortgage; (2) breach of the note and mortgage; (3) acceleration; and (4) damages. Plaintiff had standing to foreclose pursuant to § 673.3011(1), Florida Statutes. The Court further finds Defendants have not proven any avoidances to the entry of final summary judgment of foreclosure.

2. **Amounts Due.** Plaintiff, Lakeview Loan Servicing, LLC, 4425 Ponce de Leon Blvd., MS 5-251, Coral Gables, FL 33146, is due:

3. **Interest.** The total amount in paragraph 2 must bear interest from this date forward at the prevailing statutory rate of interest.

4. **Lien on Property.** Plaintiff holds a lien for the total sum superior to all claims or estates of defendant(s), (with the exception of any assessments that are superior pursuant to Section 718.116, or 720.3085, Florida Statutes) on the following described property in Okeechobee County, Florida:

**THE NORTH ONE HALF OF LOT 4 AND THE WESTERLY FIVE FEET OF THE NORTH ONE-HALF OF LOT 3, BLOCK A, CENTRAL PARK SUBDIVISION, ACCORDING TO THE PLAT THEREOF RECORDED IN PLAT BOOK 2, PAGE 39, PUBLIC RECORDS OF OKEECHOBEE COUNTY, FLORIDA.**

**PROPERTY ADDRESS: 301 SE 5TH AVE, OKEECHOBEE, FL 34974**

5. **Sale of Property.** If the total sum with interest at the rate described in paragraph 2 and all costs accrued subsequent to this judgment are not paid, the clerk of this court must sell the property at public sale on January 14, 2026 to the highest bidder for cash, except as prescribed in paragraph 6, by electronic sale at Okeechobee beginning at 11:00 a.m. <https://okeechobee.realforeclose.com> in accordance with section 45.031, Florida Statutes. **The public sale must not be postponed or canceled without a court order. All orders postponing or canceling the sale must be filed with the clerk of court no later than 5:00 p.m. five (5) business days before the sale date. Counsel for plaintiff must be certain that all sale and clerk fees are paid and that the original proof of publication is filed no less than five (5) business days before the sale date. Failure to timely file the original proof of publication of the notice of sale and pay the sale and clerk fees will stop the sale. Additionally, the failure of plaintiff's counsel to pay the sale fee and properly and timely publish the notice of sale may result in sanctions against the plaintiff, plaintiff's counsel individually, and the law firm representing the plaintiff.** Any electronic sale by the clerk must be in accordance with the written administrative policy for electronic sales published by the clerk at the official website for the clerk and posted in the public areas of the clerk's offices.

6. **Costs.** Plaintiff must advance all subsequent costs of this action and must be reimbursed for them by the clerk if plaintiff is not the purchaser of the property for sale, provided, however, that the purchaser of the property for sale must be responsible for the documentary stamps payable on the certificate of title. If plaintiff is the purchaser, plaintiff must file an affidavit within 5 business days and the clerk must credit plaintiff's bid with the total sum with post-judgment interest and costs accruing subsequent to this judgment, or such part of it, as is necessary to pay the bid in full. The clerk must receive the service charge imposed in Section 45.031, Florida Statutes.

7. **Distribution of Proceeds.** On filing the certificate of title, the clerk must distribute the proceeds of the sale, so far as they are sufficient, by paying: first, all of plaintiff's costs; second, documentary stamps affixed to the certificate; third, plaintiff's attorneys' fees; fourth, the total sum due to plaintiff, less the items paid, plus interest at the rate prescribed in paragraph 2 from this date to the date of the sale; and by retaining any remaining amount pending further order of this court.

8. **Right of Redemption.** On filing the certificate of sale, defendant(s) and all persons claiming under or against defendant(s) since the filing of the notice of lis pendens must be foreclosed of all estate or claim in the property, and defendant's right of redemption as prescribed by section 45.0315, Florida Statutes, must be terminated, except as to the rights of a bona fide tenant occupying residential premises under the federal Protection Tenants at Foreclosure Act, 12 U.S.C. sec. 5220, note, or section 83.5615, Florida Statutes, and claims or rights under chapter 718 or chapter 720, Florida Statutes, if any.

9. **Right of Possession.** On the filing of the certificate of title, the person named on the certificate of title must be let into possession of the property subject to the rights of a bona fide tenant occupying residential premises under the Federal Protecting at Foreclosure Act, 12 U.S.C. sec 5220, note, or section 83.5615, Florida Statutes. If any defendant or tenant remains in possession of the property, an Order Granting the Motion for Writ of Possession must be entered without further notice or hearing, subject to the purchaser's compliance with Section 83.5615, Florida Statutes.

10. **Attorney's Fees.** The requested attorneys' fees are a flat rate fee that the firm's client has agreed to pay in this matter. Given the amount of the fee requested and the labor expended, the court finds that a lodestar analysis is not necessary and that the flat fee is reasonable.

11. **Jurisdiction Retained.** Jurisdiction of this action is retained to enter further orders that are proper including, without limitation, a deficiency judgment, writs of possession and such supplemental relief or judgments as may be appropriate.

12. **Additional Advances.** If subsequent to the date of the Plaintiff's affidavit of indebtedness and/or this final judgment of foreclosure, and prior to the sale contemplated in this final judgment, the Plaintiff has to advance money to protect its mortgage lien, including but not limited to post-judgment advances for property taxes and insurance, property preservation costs, post judgment attorney's fees and costs and post judgment bankruptcy attorney fees and costs, the Plaintiff or its attorneys shall certify by affidavit to the Clerk any such advances, and the amount due to Plaintiff shall be increased by the amount of such advances without further order to the Court.

13. **Reformation of Deed & Mortgage.** This Court has determined that the legal description contained within the mortgage given by JUDITH DIANNE DANIELS, to the payee named thereon executed on May 4, 2018, and recorded in Official Records Book 807 at Pages 4 of the Public Records of Okeechobee County, Florida, and the warranty deed executed between Mary D. Hagan and Judith Dianne Daniels on May 4, 2018 and recorded in Official Records Book 807 at Page 1 of the Public Records of Okeechobee County, Florida, were incorrect. The legal description of the mortgage and deed shall hereby reformed to reflect the correct legal description, and shall hereafter be referred to by the following legal description:

**THE NORTH ONE-HALF OF LOT 4 AND THE WESTERLY FIVE FEET OF THE NORTH ONE-HALF OF LOT 3, BLOCK A, CENTRAL PARK SUBDIVISION, ACCORDING TO THE PLAT THEREOF RECORDED IN PLAT BOOK 2, PAGE 39,**

**PUBLIC RECORDS OF OKEECHOBEE COUNTY, FLORIDA.**

14. **FHA Loan:** Under the terms of the Note and Mortgage, interest on the principal balance accrued monthly on the first day of each month.


